Kentucky Power Company's First Quarter 2022 Status Report

Kentucky Power Company ("Kentucky Power") provides the following report on the status of the efforts of Unity Aluminum, Inc. ("Unity") to secure financing to complete construction of the facilities to be built in EastPark Industrial Park, and of Kentucky Power's land acquisition for the transmission line and substation:

1. Kentucky Power contacted Unity in April 2022 in connection with the preparation of this report.

2. Unity confirmed it continues to work to secure financing to complete construction of the facilities described in the contract. Unity indicated it currently was unable to provide an estimate of when sufficient financing would be secured to complete construction of its facilities described in the Contract for Firm Electric Service Between Kentucky Power Company and Braidy Industries, Inc. n/k/a Unity.

3. Kentucky Power has acquired 21 of the 22 parcels required for the substation and transmission line as of March 31, 2022. Please see **EXHIBIT 1** to this status report for further

details of Kentucky Power's property acquisition. The outstanding parcel is the proposed substation site and a related easement.

4. Kentucky Power will file its next status report following the close of the second quarter of 2022.
