MOTION FOR CONFERENCE WITH COMMISSION STAFF

Mountain Water District ("Mountain District") moves for a conference with Commission Staff to discuss the proposed inspection schedule for Mountain District's grinder/pump stations and for the preparation of a digital video transcript of such conference's proceedings.

Mountain District will make available at the proposed conference a representative from Environment One Corporation, the manufacturer of Mountain District's grinder/pump stations, to discuss the features of those grinder/pump stations, their reliability, and their required maintenance. This representative will also discuss the aspects of the grinder/pump stations that can be inspected without physically removing the pumping station to a maintenance facility.

At the conference, Mountain District's representatives can also provide additional information regarding its calculations on the cost of inspecting its grinder/pump stations and address questions regarding those calculations, Mountain District's procedures and past history in responding to customer reports of problems with those stations, and any other areas that Commission Staff finds relevant.

The requested conference is a cost-effective and timely means of obtaining additional information regarding the grinder/pump stations and Mountain District's requested relief. By enabling Commission Staff to physically examine a representative grinder/pump station and

directly question the grinder/pump station's manufacturer, the requested conference will ensure a more complete record. The preparation of a digital video transcript of the conference's proceedings will create an accurate and complete record of the conference for the members of the Commission and assist them in their deliberations.
