



Preparations for the 2018 United Soccer League Cup playoffs continued Tuesday for Futbol Club Cincinnati with the announcement of the dates and times for the first two rounds of the playoffs.

Having already clinched home matches at Nippert Stadium for the first two rounds of the playoffs, FC Cincinnati will open its postseason campaign on Saturday, Oct. 20, at Nippert Stadium with a scheduled 4 p.m. kickoff.

Should Cincinnati advance, it would then host the Eastern Conference semifinals on Saturday, Oct. 27, at 4 p.m.
