



Question No. 1

Responding Witness: Dean M. Hall, Manager of Southern District

Q-1. Refer to Southern District's response to the Commission Staff's Post Hearing Request for Information. Southern District was asked to provide Floyd County Fiscal Court meeting minutes for October, November, and December 2018. In its response, Southern District provided minutes for its meetings and not minutes for the Floyd County Fiscal Court.

- a. Provide the Floyd County Fiscal Court meeting minutes for October, November, and December 2018.
- b. Explain why Southern District failed provide the information as requested.

A-1a. The Floyd County Fiscal Court Minutes for October, November, and December 2018 attached as Exhibits 1, 2 and, 3 respectively.

A-1b. Southern inadvertently attached its own Minutes for October, November, and December 2018, instead of the Floyd County Fiscal Court's Minutes for those same months. Southern does not keep the records or minutes of the Floyd County Fiscal Court on file in its office. However, Southern contacted the Floyd County Fiscal Court staff and was able to obtain the Minutes for October, November, and December 2018.
