RE: Financial Condition of Southern, Rate Increase Application, and Project Information

Dear Ms. Johnson & Board Members:

This letter is to serve as a summary of where we are with the Alternative Rate Filing, discussion of surcharges allowed by the PSC, and the status of the two Kentucky Infrastructure Authority projects – Mink Branch water storage tank and Lackey to Wayland Water Line Replacement.

First off, the financial health of the District is in grave condition. The District is losing approximately \$60,000 per month with the release of over 1,200 customers to the City of Prestonsburg in July 2017. The only reason the District has remained solvent to date is that the City of Prestonsburg is paying Southern for the assets of the District turned over to them. Once they have paid 100 percent of the stated value of the assets, these losses will become very real, very fast to the District.

Considering the continued worsening of the District's financial condition, KY Engineering Group has prepared an Alternative Rate Filing. This is a more expedited procedure for smaller utilities to request a rate adjustment through the Public Service Commission.

As presented to the Board at the February 2018 meeting; the Alternative Rate Filing calculates a need for a 48.55 percent increase in the average bill (4,000 gallons). This includes depreciation at 100 percent. If we reduce the percentage of depreciation in the rate calculation to 50 percent, the percentage increase on the average bill drops to 35.75 percent and if depreciation is taken out entirely, then the percentage drops to 20.53 percent. However, it is not known what the PSC will do if depreciation is not in the calculations or at a less than 100 percent amount. They could require that we add it back in.

I have had two conversations with Mr. Michael Schmitt, Chairman of the Public Service Commission. These conversations were regarding the ability of the District to place a surcharge on its customers. Mr. Schmitt said that surcharges are always done as part of a rate application. There is no procedure in place currently to allow a District to institute a surcharge alone. He has asked PSC attorneys to investigate how to allow this but cautioned this would not happen fast.

Mr. Schmitt also stated that a surcharge is allowed as part of a rate application only for dealing with water loss. A very specific plan must be filed to show how the surcharge will be used to reduce water loss. Surcharges are collected and placed in a restricted account and permission must be

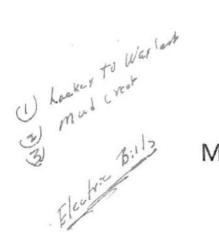
