Due solely to the recent approval by the Kentucky Public Service Commission ("KPSC") of an increase in purchase rates for water supplied by Kentucky American Water Company, the Jessamine-South Elkhorn Water District ("JSEWD") filed an application with the KPSC for approval of an adjustment in rates effective July 1, 2018.
