Please accept this cover letter, meant to amend and supplant the one filed by Sierra Club yesterday, January 16, 2019, contemporaneous with the testimony referenced herein. Today, PSC staff brought to my attention that Sierra Club's cover letter filed yesterday did not acknowledge the basis for the confidential treatment of certain information that Sierra Club redacted in the public version of Dr. Fisher's testimony filed yesterday. Per the instructions Sierra Club received today as to how to correct that deficiency, I submit this amended cover letter, which includes recognition of the basis for such confidential treatment.

Yesterday's cover letter stated the following:

Please find enclosed for filing one copy of Amy Waters, Joe Dutkiewicz and Sierra Club's Redacted Testimony of Jeremy Fisher, with exhibits, in Case No. 2018-00295, Adjustment of Rates for Louisville Gas & Electric Company before the Kentucky Public Service Commission. These documents are also being filed electronically. The above named parties were granted intervenor status by the order of the Franklin Circuit Court in *Sierra Club et al. v. Public Service Commission of Kentucky et al.*, Civil Action No. 18-CI-1129.

The electronically filed documents are a true representation of the original documents to be filed with the Commission. The unredacted version of this testimony, containing confidential information, is being filed in paper form under seal.

Sierra Club hereby amends the cover letter filed yesterday so as to indicate, further, that all of the redactions in the public version of Dr. Fisher's testimony filed yesterday were made exclusively for the purpose of honoring and continuing the confidential treatment afforded to the same substance by Louisville Gas & Electric Company in discovery responses previously provided by the Company to Sierra Club—specifically, in the discovery responses cited by Dr. Fisher in the redacted portions of his testimony. When the Company had provided Sierra Club with its discovery responses, the Company had contemporaneously filed Petitions for Confidential Protection with the Commission—namely, on December 6, 2018 (responding to Sierra Club's first set of discovery requests) and on January 2, 2019 (responding to Sierra Club's second set of discovery requests). Accordingly, and consistent with the Confidentiality Agreement that Sierra Club executed with the Company, Sierra Club's publicly filed direct testimony included redactions only to maintain the confidentiality of the same substance that the Company had previously designated as protected. Sierra Club did not redact anything for any other reason; its redactions exclusively relate to, and flow from, the Company's aforementioned designations and Petitions for Confidential Protection.

This amended cover letter is being electronically filed with the Commission today, and a copy of the same is being delivered to the Commission in paper form.
