**STATUTORY NOTICE**

Louisville Gas and Electric Company (“LG&E”), by counsel, informs the Kentucky Public Service Commission (“Commission”) that it is engaged in business as an operating public utility, principally furnishing retail electric and gas service in Jefferson County, Kentucky, and portions of 15 other counties in the surrounding area within Kentucky.

Pursuant to KRS 278.180, LG&E gives notice to the Commission that, on September 28, 2018, it files herewith its application for adjustment of rates and proposes to adjust its rates in conformity with the tariff sheets (“the revised tariffs”) attached to that application at Tab 4 of the Filing Requirements and made a part hereof by reference.

LG&E proposes to change its existing rates and terms and conditions of service in its tariff for electric and gas service, now on file with and approved by the Commission, by substituting the revised tariff sheets for the corresponding tariff sheets in its existing tariff and by amending the rates and charges or terms and conditions set forth in certain special contracts for electric and gas service.

Notice is further given that the stated effective date for these changes is November 1, 2018, greater than thirty days from the date of filing, pursuant to KRS 278.180 and 807 KAR 5:011. LG&E files its application and provides this notice with the expectation that the Commission will subsequently order the customary six-month suspension of the proposed

rates pursuant to KRS 278.190. LG&E, therefore, requests that the Commission conduct its review during this suspension period and issue an order permitting new base rates to take effect for service rendered on and after May 1, 2019.

Notice to the public of the proposed rates is being given as prescribed by the Commission's regulations, subject to the modifications approved and directed by the Commission in its Order of August 31, 2018 in Case No. 2018-00250.<sup>1</sup> The forms of notice that LG&E has provided to the public include the posting on LG&E's website of a complete copy of the application in this case and a hyperlink to the Commission's website whether the documents related to this case are available and the posting and display of the full customer notice for inspection at the offices of LG&E, 820 West Broadway, Louisville, Kentucky 40202. A copy of the full customer notice required by 807 KAR 5:001 Section 17 is posted and may be viewed in each public library located within LG&E's service territory. A Certificate of Completed Notice will be filed with the Commission in accordance with 807 KAR 5:011, Section 8 (3).


Additional information required by the Commission's regulations is contained in the application filed herewith and made a part hereof by reference.




