**JOINT ERRATA FILING**


Kentucky Utilities Company (“KU”) and Louisville Gas and Electric Company (“LG&E”), by counsel, hereby give notice of the following correction to Original Sheet No. 72 of the electric tariffs submitted to the Commission as Stipulation Exhibits 6 (KU) and 7 (LG&E) attached to the March 1, 2019 Stipulation. That paragraph states in relevant part:

Each billing period during which the Subscriber has paid in full for subscribed capacity under either option above, Company will compare a subscribing customer’s pro rata AC energy produced by the Solar Share Facilities (**truncated to a whole kWh value**) to the subscribing customer’s energy consumption (in kWh) every 15 minutes.

Although the Companies included the emphasized text shown above (“truncated to a whole kWh value”) in their filing, during the IT programming process it was discovered that the text could eliminate energy credits for small amounts of pro rata energy production from the Solar Share Facilities (e.g., by truncating 0.4 kWh produced to 0 kWh). The Companies propose to correct this issue by deleting the emphasized text and replacing it with “(in kWh)”. This correction will ensure customers receive accurate kWh-denominated credits for the energy produced by their subscribed portions of the Solar Share Facilities.
