Louisville Gas and Electric Company ("LG&E") is filing revised Gas Supply Clause tariff sheets and responses to the Commission's information request Ordered in Case No. 2018-00182. Additional details are provided below.

Gas Supply Clause

LG&E is filing, in electronic medium, pursuant to the provisions of the Company's Gas Supply Clause as authorized by the Commission, revised tariff sheets of LG&E Tariff PSC Gas No. 11. The revised tariff sheets set forth a Gas Supply Cost Component applicable to all gas sold during the period of November 1, 2018 through January 31, 2018. The Gas Cost Actual Adjustment and the Gas Cost Balance Adjustment levels are changed from the levels that were implemented on August 1, 2018.
