**MOTION TO SUBMIT CASE FOR ADJUDICATION**  
**ON THE ADMINISTRATIVE RECORD**

Comes now East Kentucky Power Cooperative, Inc. (“EKPC”), by counsel, and, for itself and on behalf of its sixteen Members, hereby moves the Kentucky Public Service Commission (“Commission”) to submit the case for a decision based upon the existing record and without the need for a hearing, respectfully stating as follows:

On September 20, 2018, the Commission issued an Order opening an investigation for the six-month review of EKPC’s environmental surcharge and pass-through mechanisms. The September 20, 2018 Order contained a procedural schedule that allowed for the filing of direct testimony, data requests, and a deadline for motions to intervene in the case. EKPC and its Members have provided all of the requested information and there have been no motions for intervention filed in this case. EKPC and its Members have until January 30, 2019, to request a hearing or submit the case for a decision on the existing record.

Since the remainder of the procedural schedule only applies to intervenors, and there are no intervenors in this case, EKPC and its Members believe the administrative record is complete

and it would be appropriate for the Commission to make a ruling based upon the record. EKPC and its Members respectfully request a decision from the Commission based upon the existing record.

WHEREFORE, EKPC and its Members move the Commission to submit the case on the existing administrative record.
