Request 1. Provide the inputs and outputs of the budget model that EKPC utilizes to determine the overall cost of fuel in Excel spreadsheet format with all formulas intact and unprotected, and with all columns and rows accessible

Response 1. EKPC is unable to provide the requested inputs and outputs of the budget model it uses to determine the overall cost of fuel because the software used is not in Excel spreadsheet format. The model used by EKPC utilizes an application developed by EKPC that stores information in a centralized database that resides on EKPC's internal corporate network and is not available from any outside vendor. However, as stated in EKPC's response to Request No. 1 of the Commission's first Post-Hearing Data Request, EKPC is willing to demonstrate the model to the Commission and its Staff at EKPC's offices.
