**MOTION FOR LEAVE TO DEVIATE
FROM COMMISSION ORDER**

Comes now Jackson Purchase Energy Corporation (“JPEC”), by counsel, and hereby moves the Commission for leave to deviate from certain deadlines set forth in the Order entered herein on February 11, 2019 (the “Order”). In support of this request, JPEC states as follows:

1. The Commission established this proceeding pursuant to the Order, wherein it directed JPEC to file, *inter alia*, an Affidavit of Compliance by March 4, 2019, and responses to certain requests for information by March 13, 2019.
2. Through oversight, inadvertence, and/or excusable neglect, JPEC failed to comply with the Commission’s stated deadlines. JPEC is filing contemporaneously with this Motion the required Affidavit and responses to requests for information. While JPEC strives to fulfil all its obligations as a Commission-regulated utility, internal miscommunication and misunderstanding resulted in this untimely submission. JPEC has already arranged for publication of notice consistent with paragraph 4 of the Commission’s Order and fully intends to file an Affidavit of Publication of Hearing with the Commission on or before April 15, 2019.

3. JPEC respectfully requests that the Commission accept its late-filed Affidavit of Compliance and its late-filed responses to the Commission's requests for information. Due to the scope and subject matter of this proceeding, as well as the time remaining before the scheduled hearing (April 16, 2019), JPEC does not believe the deviation it requests will result in prejudice or unreasonably impact the Commission's consideration of relevant issues. JPEC endeavors to ensure the timely progression of this case going forward and hopes to avoid any delay in concluding the Commission's examination.

WHEREFORE, for good cause shown, JPEC respectfully requests that the Commission enter an Order granting JPEC permission to late-file the documents described herein and thereby deviate from the deadlines set forth in the Commission's Order entered herein on February 11, 2019.
