NOTICE

On or about June 13, 2019, Estill County Water District No. 1 ("Estill District") will file an application with the Kentucky Public Service Commission for the purpose of adjusting its water rates. In this application, Estill District proposes to assess, effective July 15, 2019, a minimum monthly surcharge of \$3.54 on customer bills, the proceeds of which would be used for water loss reduction efforts. Estill District also proposes a series of controls and accountability measures to ensure the proper use of surcharge proceeds.

Since 2014 Estill District has experienced an unaccounted-for water loss rate in excess of 35 percent. For every three gallons of water purchased since then, Estill District has recorded sales of less than two gallons of water. A recent report on Estill District's water losses prepared at the direction of the Kentucky Public Service Commission estimated that if no action is taken to reduce Estill District's water loss, its water losses will exceed its actual meter sales by 2026. Estill District's present rates for water service do not provide for any water loss reduction efforts and Estill District currently lacks sufficient funds to undertake recommended measures to reduce water loss. In its application, Estill District proposes the following monthly rates:
