MOTION FOR EXTENSION OF TIME TO COMPLY WITH ORDER OF NOVEMBER 22, 2019

Big Sandy Water District moves for an extension of time until January 31, 2021 in which to comply with the provisions of the Order of November 22, 2019. In support of this Motion, Big Sandy Water District states:

- 1. In its Order of November 22, 2019, the Public Service Commission ("Commission") directed Big Sandy Water District to take several actions, including the development of new policies and procedures to address water loss and better business practices, the development of a plan to ensure its compliance with the meter testing requirements of 807 KAR 5:066, Section 16.
- 2. The primary person responsible for the development of these policies and procedures has been Teresa Brown, Big Sandy Water District's General Manager. Ms. Brown retired unexpectedly early this month. At the time of her retirement, Ms. Brown had not completed this work.
- 3. Big Sandy Water District requires additional time to complete this work. The additional time will permit the water district's staff and interim general manager to review and complete Ms. Brown's work.
- 4. The requested extension of time will also allow Big Sandy Water District to incorporate the results of the comprehensive water audit which it is currently preparing with the

assistance of Kentucky Water Resources Research Institute, into its plans and procedures. The Commission has previously authorized Big Sandy Water District an extension of time until January 31, 2021 to complete and submit the results of a comprehensive water audit.

5. The requested extension of time is not for the purposes of delay. It will permit Big Sandy Water District to complete the required documents in a thorough and thoughtful manner.

WHEREFORE, Big Sandy Water District requests that the time period to comply with the provisions of the Commission's Order of November 22, 2019 be extended to January 31, 2021.
