## WEST CARROLL WATER DISTRICT'S MOTION FOR EXTENSION OF TIME

Comes now West Carroll Water District ("West Carroll"), by and through the undersigned counsel, and requests an extension of time to file the documents requested in the Commission's November 22, 2019 Order. As grounds for this motion West Carroll respectfully states as follows:

The Commission's Order required certain information to be filed within six months from the date of the Order. Specifically, this information includes the following:

- Plans to improve the operations and financial health of the utility;
- New policies and procedures to address water loss and better business practices, including but not limited to a water loss reduction plan, a leak detection plan and improved employee policies and procedures;
- Revised leak adjustment policy; and
- Written report on the merger discussion status.

Exhibit K to the Commission's Order stated that West Carroll should undertake discussions with Carrollton Utilities regarding a merger or consolidation. On March 3, 2020 West Carroll filed a Motion requesting and extension of time until September 22, 2020 to comply with the Commission's November 22, 2019 Order. Just a few weeks after that Motion was filed, Governor Beshear declared a state of emergency for the state of Kentucky and many offices and businesses

were closed. This put a halt on any discussions between West Carroll and Carrollton Utilities regarding a merger or a consolidation.

Now that some of the restrictions are beginning to be lifted, West Carroll and Carrollton Utilities have begun to restart the merger discussions. However, due to the unforeseen circumstances surrounding COVID-19, these discussions will not be finalized prior to the September 22, 2020 deadline. West Carroll still believes that its time over the next few months would be well spent having further merger discussions with Carrollton Utilities and other necessary entities negotiating the details of such merger or consolidation.

To date there have been numerous discussions with West Carroll board members, Commissioners, the mayor, city council members and county judge. There have also been two joint meetings of West Carroll and Carrollton Utilities' boards and a meeting involving the mayor, the new Department of Local Government Commissioner Keene, the Executive Director of Kentucky Infrastructure Authority, Edith Halbleib and Representative Rick Rand to discuss any potential loan forgiveness or available grant money to monetarily assist in a merger or consolidation of West Carroll and Carrollton Utilities. Meetings have been requested and are awaiting final confirmation to further discuss the issues involved with any merger or consolidation.

The documents required to be filed by West Carroll pursuant to the Commission's Order are very time consuming to develop. Furthermore, if the merger negotiations are successful and West Carroll and Carrollton Utilities consolidate, West Carroll customers would then be under the policy and procedures of Carrollton Utilities. Having West Carroll go through the time and expense of developing these documents when they may change again if the merger discussions are successful would seem to create some customer confusion as to the policies and procedures in place if a merger were to occur in the near future. West Carroll proposes the requested extension

in order to continue merger discussions and should have a much better idea of the merger discussions over the next several months if a merger will occur.

Therefore, West Carroll would request an additional four-month extension to December 22, 2020 to provide the documentation ordered by the Commission. West Carroll will continue to file the monthly updates it has been filing since April with the Commission regarding the merger discussions.
