RESPONSE TO COMMISSION'S MARCH 13, 2019 ORDER

Comes B&H Gas Company and Bud Rife, Individually and as an Officer of B&H Gas Company ("Respondents"), by counsel, and for their Response to the Commission's March 13, 2019 Order, respectfully state as follows:

Bud Rife has suffered two heart attacks within the last 3 weeks. First, he was hospitalized from March 4 to March 7, 2019 and was again hospitalized from March 12 to March 14, 2019. As a result, the doctors have placed two stents in Mr. Rife for the purpose of increasing blood flow to the heart. He has been told that by placing the additional stent in his artery, which was found to be 90% blocked, he may be able to avoid bypass surgery. Mr. Rife has now been released to return to work on light duty.

Mr. Rife has returned to the office for light duty work, including assisting Suda Allen, office manager for the company, and Robert Newsome. His present duties are limited to office work, billing, paying bills, and generally overseeing the day to day office activities. He has not been released to return to heavy lifting or operating heavy equipment.

In Mr. Rife's absence, his heavy lifting and heavy equipment operating duties have been assumed by Jimmy Lawson, an employee of Bud Rife Construction Company. Mr. Lawson is a long-time employee of the construction company and is very familiar with the pipelines and infrastructure of B&H Gas Company. Mr. Lawson is Operator Qualified (OQ) pursuant to DOT and PHMSA regulations regarding pipeline certifications.
