Thank you for applying for the Pipeline and Hazardous Materials Safety Administration's (PHMSA) fiscal year (FY) 2022 Natural Gas Distribution Infrastructure Safety and Modernization (NGDISM) grant. We regret to inform you the City of Drakesboro was not selected to receive an award.

PHMSA received 179 NGDISM grant applications for FY 2022. The review process was very competitive, and applicants proposed many worthwhile projects. However, the total funding requested by applicants well exceeded our available FY 2022 grant funding. PHMSA assigned the City of Drakesboro's application a rating of "Acceptable," noting that the City's application did not provide sufficient detail regarding monitoring efforts, internal controls, and quality assurance plans to ensure the project's success and did not appropriately address physical and cyber security. Because of this, PHMSA identified other applications that were deemed to be a higher priority for award based on the factors listed in the Notice of Funding Opportunity (NOFO).

We encourage the City to apply for future grants and will notify you when the FY 2023 NDGISM NOFO is posted to Grants.gov. If the City would like to further discuss the application decision, please contact the NGDISM Grant Team at PHMSAPipelineBILGrant@dot.gov.


