**KENTUCKY-AMERICAN WATER COMPANY’S**  
**MOTION FOR EXTENSION OF TIME**


The Commission’s April 23, 2019 Order in this matter approved Kentucky-American Water Company’s (“KAW”) continued participation in the American Water Capital Corporation (“AWCC”) borrowing program and authorized KAW to issue securities in the form of notes or debentures as described in KAW’s March 8, 2019 Application prior to December 31, 2021. KAW issued long-term debt in the amount of \$16,000,000 on May 22, 2019. As required by Ordering Paragraph 4 of the Commission’s April 23, 2019 Order, on May 7, 2019, KAW gave fifteen days’ advance notice of that May 22, 2019 issuance. Ordering Paragraph 5 of the Commission’s April 23, 2019 Order also requires KAW to file certain information describing the terms of the issuance and the estimated savings realized from participating in the AWCC borrowing program within ten days after the issuance, which would be June 3, 2019.<sup>1</sup> KAW requires additional time to gather the information necessary, and, therefore, respectfully requests to and including June 13, 2019 to file the information required by Ordering Paragraph 5.


