

Developers are pitching proposals to Developers are pitching proposals to build subdivisions and recreational projects on land where the historic Gamble house in Westwood used to stand. The Greenacres Foundation, which owns the 22-acre property at 2918 Werk Road, asked the Home Bullders Association of Greater Cincinnati and other interested parties earlier this summer to submit proposals and purchase prices by Aug. 1.
"We got several proposals from de-

"We got several proposals from developers/bulders to put in a subdivision of varying density. We also received a proposal that the property would become a park and one to make an event center," Greenacres President Carter Randolph said.

"We are not revealing anything more about the proposals and we will work through them and see if we think there is one that stands out."



"All proposals have merits and will be given consideration, but none have been chosen or el-minated from consideration," Rando-in said.
