Applicants' Motion for Extension of Time to Respond to Attorney General's Initial Data Requests

Bluegrass Water Utility Operating Company, LLC ("Bluegrass Water") P.R. Wastewater Management, Inc., Marshall County Environmental Services LLC, LH Treatment Company, LLC, Kingswood Development, Inc., Airview Utilities, LLC, Brocklyn Utilities, LLC, Fox Run Utilities, LLC, and Lake Columbia Utilities, Inc. (collectively, "Applicants"), hereby move for an extension of time by which to respond to the Attorney General's Initial Data Requests. In support of this Motion, the Applicants state as follows:

- 1. Pursuant to ¶5 of the Commission's May 9, 2019 scheduling order, the deadline for the Applicants' Response to initial Requests for Information is May 31, 2019.
- 2. Applicants are in need of additional time to prepare appropriate responses and verify several of the remaining Initial Data Requests (Nos. 10-13, 15-16).
- 3. On May 31, 2019, Applicants' counsel and the AG representative in this matter discussed Applicants' need for an extension to respond to the remaining data requests, and the AG agreed to such an extension, subject to the condition that for any response filed by

Applicants after the 5/31/19 deadline, the AG shall be allowed an extension for the same number of workings days after the 6/7/19 supplemental information request deadline by which to serve follow-up requests relating to the delayed response.

4. This extension would allow both Applicants and the AG to fully satisfy their obligations in responding to the requests for information and/or serving supplemental information requests in time for the hearing to be scheduled in the Commission's investigation of the proposed acquisition and transfer.

WHEREFORE, Applicants respectfully request that the Commission grant an extension for Applicants to respond to certain of the AG's initial data requests, and an extension for the AG to then file supplemental information requests thereto.
