Notice re Condition #5 (guaranteed financial instrument)

Please take notice that Bluegrass Water Utility Operating Company, LLC ("Bluegrass Water"), having requested an informal conference to discuss how it will meet the financial-instrument requirement, will proceed to post a guaranteed financial instrument in accordance with that discussion after the informal conference is held. The approval orders in Cases No. 2019-00104 and No. 2019-00360, respectively entered August 14, 2019, and February 17, 2020, each include as Condition #5 in the Appendix thereto the condition that Bluegrass Water "post a guaranteed financial instrument that is the equivalent of two-months of the cost of its third-party contractors" for the sewer systems approved to be acquired.

In December 2019, in Case No. 2019-00104, Bluegrass Water filed a Motion along with a proposed Letter of Credit ("LoC") and requested that the Commission approve the LoC or otherwise provide guidance on its suitability as the required financial instrument. After the Commission specified a similar condition in the 2/17/20 Order, and in recognition that the proposed LoC would need to be revised to cover the condition in the 2/17/20 Order and that alternatives to the LoC would be more cost-effective, Bluegrass Water withdrew the LoC proposal and requested the informal conference. The Motion-Notice was filed on June 16, 2020, and Bluegrass Water anticipates that the informal conference will be held before mid-July 2020.
