

### ORDER DISCHARGING TEMPORARY RECEIVER

On joint motion of the Commonwealth of Kentucky Energy and Environmental Cabinet and the Paducah-McCracken County Joint Sewer Agency, ("PMJSA") as temporary receiver for the Great Oaks Subdivision Wastewater Treatment Plant ("Great Oaks WWTP"), the temporary receiver having been appointed by an Order of this Court on August 9 2019, hereby rules as follows:

### IT IS HEREBY ORDERED AND ADJUDGED:

1. PMJSA is hereby discharged of all duties, responsibilities and liabilities as to the receivership effective as of September 30, 2019. If for any reason the closing of the acquisition between Marshall County Environmental Services/Allen Artis and Bluegrass Water Utility Operating Company or its affiliate fails to occur on September 30, 2019, PMJSA shall remain the temporary receiver of the Great Oaks WWTP until the parties tender additional information to the Court.

2. PMJSA is hereby granted a period of fifteen (15) days to submit for the Court's review and acceptance, a final accounting and report of the receivership. Upon the Court's acceptance of the final accounting and report, the Court will enter an Order dismissing the case.
