## ATTORNEY GENERAL'S MOTION FOR EXTENSION OF TIME

Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and hereby moves the Kentucky Public Service Commission ("Commission") for a one-day extension to file his request for commitments to the Joint Applicants in this matter. In support of his Motion, the Attorney General states as follows:

Although the Commission has not yet entered an order in this matter requiring the Attorney General's request for commitments to be filed by a particular date, the Commission and counsel for the parties agreed that the Attorney General would file them by July 11, 2019. The verbal agreement at the hearing required the Joint Applicants to respond to the commitments by July 18, 2019. Undersigned counsel for the Attorney General has been engaged and in attendance at three (3) other hearings at the Commission since the conclusion of the hearing in this matter. In the interim, the Attorney General has already drafted and filed his Post-Hearing Data Requests in this case. Given the strain on time and resources the intervening hearings have placed on the Attorney General's office, the Attorney General respectfully requests one (1) additional day, until July 12, 2019, to file his requests for commitments to the Joint Applicants. Counsel for the

Attorney General has spoken with counsel for the Joint Applicants, who stated that they have no objection to this one-day extension of time as long as the Joint Applicants have one (1) additional day (until July 19, 2019) to respond to the requests for commitments. Of course, the Attorney General agrees that Joint Applicants should have a corresponding amount of additional time to respond, as they should not be prejudiced by the Attorney General's Motion. The only party negatively affected by the one-day extension is the Attorney General himself, insofar as he will have one less day to review the commitments agreed to and determine how to incorporate those commitments (or lack of commitments) in his ultimate brief in this matter.

WHEREFORE, the Attorney General respectfully moves the Commission for a one-day extension of time in which to file his request for commitments to the Joint Applicants, as well as one corresponding day, for a total of seven (7), for the Joint Applicants to respond.
