MOTION FOR DEVIATION AND FOR AUTHORIZATION TO COMMENCE BILLING PROPOSED SURCHARGE SUBJECT TO REFUND

Pursuant to 807 KAR 5:001, Section 22, and KRS 278.190, Estill County Water District No. 1 ("Estill District") moves for a deviation from the notice requirements set forth in 807 KAR 5:001, Section 17, and for authorization to commence billing the proposed monthly water loss control surcharge subject to refund.

In support of its motion, Estill District states:

- For the year ending December 31, 2018, Estill District reported an unaccountedfor water loss rate of 39.6243 percent. The accepted unaccounted-for water loss rate is 15 percent. As a result of its inability to maintain an unaccounted-for water loss rate no greater than 15 percent of purchased water, Estill District incurred additional purchased water and purchased power expense of approximately \$223,762.²
- 2. On June 13, 2019, Estill District filed with the Commission its application for authority to assess a monthly surcharge to each of its customers for the purpose of financing water loss control measures. Estill District proposed to use the proceeds of this surcharge solely for water loss control measures reviewed and approved by the Commission. It further proposed

strict reporting and accounting measures on the collection and use of the surcharge proceeds to ensure full accountability and transparency. Estill District also gave notice to the Commission that the proposed surcharge would take effect on July 15, 2019.

- 3. In accordance with 807 KAR 5:001, Section 17, Estill District requested the *Citizen Voice and Times* of Irvine, Kentucky the newspaper of general circulation for Estill County, Kentucky publish notice of the proposed surcharge in its weekly edition three consecutive times, beginning on June 13, 2019. A copy of the proposed notice submitted to the *Citizen Voice and Times* is found at Exhibit 7 of Estill District's Application and at Exhibit A of this Motion.
- 4. As of the date of this Motion, the Commission has taken no action to suspend the proposed surcharge or to "notify the applicant of any deficiencies in the application within thirty (30) days of the application's submission" as 807 KAR 5:001, Section 16(9) requires.
- 5. On or July 16, 2019, Estill District received affidavits of publication from the *Citizen Voice and Times*. These affidavits, a copy of which is attached as Exhibit B to this Motion, show that the full notice required by 807 KAR 5:001, Section 17 and request by Estill District was not published.
- 6. In light of the Commission's failure to suspend the proposed surcharge or to notify Estill District of any deficiencies in its Application by July 15, 2019 and Estill District's failure to obtain publication of a complete notice of the proposed surcharge, the legal status of the proposed surcharge is uncertain.
- 7. To resolve any uncertainty regarding the proposed surcharge's status, Estill District proposes to republish notice of the filing of its application three times in accordance with 807 KAR 5:001, Section 17. A copy of the revised notice is attached to this Motion as Exhibit C.

The first publication of the revised notice will occur on August 1, 2019. Estill District further requests that the Commission grant Estill District a deviation from the requirements of 807 KAR 5:001, Section 17 and accept Estill District's application as filed as of the date of this Motion. If such deviation is granted and its application for surcharge is accepted for filing as of the date of this Motion, Estill District waives any right or claim that the proposed surcharge became effective on July 15, 2019 by operation of law.

- 8. Estill District further requests that the Commission suspend the proposed surcharge for one day and then permit the surcharge to take effect subject to refund. Such action will mitigate the effects of any delay created by the defective publication of notice and any failure to review or otherwise process the application and will permit Estill District to begin accumulating the financial reserves necessary to take appropriate water loss control measures. Estill District will not immediately spend or obligate these surcharge proceeds as under the terms set forth in Estill District's Application, these proceeds must be kept in a separate account and may not be spent until the Commission has reviewed and approved the specific expenditure of the proceeds. If the Commission denies the request for the proposed surcharge or authorizes a lesser amount than that proposed, any excess funds collected can be easily refunded.
- 9. Estill District has a significant and material need to commence collection of the proposed surcharge as soon as possible. It currently lacks any funds to undertake the measures necessary to control its water losses. For the year ending December 31, 2018, Estill District experienced a net operating loss of \$271,532 and a total net loss of \$422,394.³ In the five years preceding 2018, it suffered a collective net loss of \$2,158,448. Allowing Estill District to begin collection of the proposed surcharge immediately will allow it to begin accumulating the funds necessary to undertake those measures.

- 1. Granting a deviation from the requirements of 807 KAR 5:001, Section 17, and accepting Estill District's application as filed as of the filing of this Motion and
- 2. Authorization for Estill District to begin immediately billing the proposed monthly surcharge subject to refund.
