## MOTION FOR CONFIDENTIAL TREATMENT

Comes now Fox Run Living, LLC, ("Fox Run") by and through counsel, pursuant to KRS 61.878 and 807 KAR 5:001, Section 13, and seeks confidential treatment for certain information filed as part of its application.

The redacted portions of the purchase contract (hereafter the "Confidential Information") contain pricing information pertaining to the purchase of the assets, including the sewer utility and apartment building. This confidential information is commercially sensitive and not publicly available. Making this confidential information public would place Fox Run at a disadvantage with regards to its competitors and potential sellers of other assets. Fox Run owns and manages a variety of residential assets, so it's highly likely that Fox Run will purchase additional similar assets in the near future. If potential sellers of other assets or competitors seeking to purchase the same or similar assets were aware of the confidential information, it would place Fox Run at a distinct commercial disadvantage.

Fox Run requests that the Confidential Information be withheld from public disclosure for a period of ten years. Preventing the public disclosure of the Confidential Information for ten

years ensures that it's commercial value to Fox Run's competitors and potential sellers will be of limited value.

WHEREFORE, Fox Run requests that the Commission enter an Order granting this motion for confidential treatment of certain information filed in conjunction with the Fox Run application and keep the Confidential Information from public disclosure for a period of ten years.
