wastewater treatment facilities acquired from Pro Man.

Updated Response:

a. As of July 24, 2019, Denizen Management has taken over management of the sewer

utility and the related apartment complex. The Contract and additional information is

attached as exhibit A. Fox Run and Denizen are currently negotiating a contract

addendum that will clarify Denizen's obligations regarding the sewer utility. Fox Run

anticipates filing an updated response with the Commission that contains the addendum

next week, but certainly before the end of this month.

Run Living asks that the Commission approve the application without the requested LOC.
