

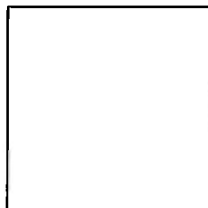

A public hearing will be conducted by the Public Service Commission of Kentucky at the offices of the Commission, located at 211 Sower Boulevard, Frankfort, Kentucky, on February 4, 2020, beginning at 9:00 a.m. Eastern Standard Time. The purpose of the hearing is to examine Kentucky Power Company and its witnesses in Case No. 2019-00154 on Kentucky Power Company's application for a certificate of public convenience and necessity to perform upgrade, replacement, and installation work at its existing substation facilities in Perry County, Kentucky (Hazard Substation), and Leslie County, Kentucky (Wooton Substation).
