ATTORNEY GENERAL'S RESPONSE TO MOTION FOR INFORMAL CONFERENCE

Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and hereby responds to Kentucky Power Company's ("Kentucky Power") Motion for Informal Conference ("Motion"). Although the Attorney General does not object to the informal conference, he provides this response for the Commission's consideration in ruling on the Motion. In its Motion, Kentucky Power states, "The purpose of the informal conference is to provide staff and any parties with an opportunity to view the substation and its condition, along with many of the elements that are the subject of Kentucky Power's application in this matter." Undersigned counsel was part of a group of stakeholders who previously sought a site visit to a different AEP (Kentucky Power's parent company) transmission structure. AEP employee, and witness in this matter, Kamran Ali stated that, "AEP does not support site visits designed to be technical inspections of specific facilities by stakeholders." Now, with Kentucky Power's pending Motion, it appears Mr. Ali's statement is no longer true. Indeed, Kentucky

Power's Motion makes clear that the informal conference will be a technical inspection. It appears that AEP will support site visits designed to be technical inspections (and even allow questions) but only in instances where AEP believes such a visit will be beneficial to its interests. In determining whether to grant Kentucky Power's Motion, the Commission must consider the standard such a decision creates.

Thanks for your recent inquiry concerning conducting a site visit to the subject line. AEP does not support site visits designed to be technical inspections of specific facilities by stakeholders. We believe such visits pose a number of significant risks and challenges and go well above and beyond the requirements of the M-3 process approved by FERC. Having said that, AEP believes it is important to educate our stakeholders in how we collect information concerning transmission line conditions for asset renewal projects. We will, therefore, be developing a one-time educational event at a selected site that provides stakeholders an opportunity to understand our asset inspection process and ask questions. We believe such an event would be of interest to other stakeholders and we would therefore expand the invitation to include others. Setting up such an event requires many considerations and it will take some time to define the specific site and the event details so that it can be done safely, legally and cost effectively. We will be back in contact with you once we have developed the event details. Please let Kelly and/or me know if you have questions.
