Amazing sights, sounds, and experiences abound if you will only step outside the confines of home and discover them. This past week produced some of those wonders, and I am richer for being a casual observer.

My grandsons visited for a few days and, of course, the rains we have faced all year long were a part of the visit. After readying their fishing poles for a foray to the pond, a sudden storm appeared!

Reese: Step outside and see Fishing was put on hold for a short while but we ventured out after the last raindrops.

Circling the sky in front of us was a huge rainbow that appeared to set at the base of Round Mountain. The boys were sure that a pot of gold sat at the foot of the multicolored arc and that they had never seen one this close. Stepping outside produced a very enjoyable and teachable moment.

While wading the Red Bird River on an excursion after the boys had left, I heard a crash through the leaves on the shore. Sounds like this can always cause a slight startle in your mind and this was no exception. Looking over towards the sound I saw a large brown bird that looked just as startled as I had been. Easing over toward

it and observing its actions seemed to indicate that the large avian was embarrassed by its predicament. Finally as I edged closer, it took off in a clumsy flight to a nearby tree. In my mind I knew it was not a hawk and thought to myself that I had just encountered a juvenile Bald Eagle. Upon returning home I researched what I had seen, and sure enough, this was what it had appeared to be. I have seen one other grown Bald Eagle in the wild, but this youngster was a first for me.

Bald Eagles are another Kentucky and United States wildlife success story. Following the ban on DDT in 1972, eagles were restocked in the 1970's and 80's in Kentucky. Since then, their number of nesting areas has increased. Most of the

increase has been around the large bodies of water in western Kentucky, but they have become more common in central and eastern Kentucky as well. Males are generally ten pounds with a six-foot wing span and females are larger growing up to 14 pounds with an eight-foot wing span. Fish are the preferred food of Bald Eagles hence their appearance along the water, but they will feed on other small animals or carrion. Even though the numbers are on an increase they still remain on our protected species list.

This national bird is a symbol of the wildness that still exists across our country. They are a symbol of national pride and following their comeback is also a symbol of national resilience.

Rainbows and eagles, they

have a lot in common this week. They appeared to my eyes, merely by stepping outside the door.

We have heard a lot about the heat wave this week, and it is to be respected, but staying indoors all the time is not the answer. Open the door and step outside; the wonders of the world are at your footstep.

We only have so many days, so it behooves us to enjoy each one and experience the sights and sounds the world has to offer.

As I write this article, the birds sing a melody to me. A closed environment would not have allowed this to happen what a song I would have missed!

According to UK plant pathologist Emily Pfeufer, late blight has been positively identified in eastern Tennessee. The late blight pathogen is Phytophthora infestans and causes this very destructive disease of tomatoes and potatoes. It can be blown several hundred miles on favorable wind currents. Under wet conditions, this disease can destroy an otherwise healthy planting in about two weeks. Photos of symptoms are linked to the following internet website: http:// veggiescout.ca.uky.edu/ lateblightontomato. The last time late blight

was influential in KY was during the 2009/2010 seasons, and systemic fungicides targeting this disease are not necessarily a routine part of tomato/potato spray programs. Thus, most growers will need assistance from county agents to adjust their program if their crops are affected by late blight. Leaves, stems, and fruit

can be affected by late blight pathogen. On foliage, individual lesions begin as water-soaked areas. Lesions can enlarge quickly, resulting in extensive blighting of foliage. Under cool and humid conditions, sporulation (whitish-gray downy-type growth) can be observed on the undersides of affected leaves. Fruit affected by late blight exhibit darkened, water-soaked spots that merge together, often covering much of the fruit. Severely infected fruit are invaded by secondary organisms, resulting in a rapid and soft decay.

to the next rain event to protect their crops from late blight. Growers in central and western KY should maintain their routine fungicide program, but scout crops for late blight symptoms, particularly after rain events. If late blight is suspected, get with your county agent to submit a sample to the Plant Disease Diagnostic Labs as soon as possible for identification. Sweet potato cannot become infected with the late blight pathogen.

To monitor the spread of late blight (free service), use the USAblight https://uswebsite: ablight.org/ where farm location can be entered and alerts can be emailed or texted to the producer. If late blight is identified in Kentucky, Dr. Pfeufer will send fol-low-up fungicide recommendations, many of which are also used to manage cucurbit downy mildew. A very good publication with great color photos of tomato, pepper, and potato pest problems is UK Extension publication ID-172, An IPM Guide for Common Pests



of Solanaceous Crops in Kentucky. Come by our office for a free copy.

OUTDOORS Reese: What's in a name?

Kentucky possesses the greatest amount of flowing navigable water in the lower 48 states. Only the huge state of Alaska is home to more flowing water. Much of this water in Kentucky comes from its border with the Ohio River and other large rivers such as the Kentucky, Cumberland, Green, Licking and other rivers that traverse the state but much comes from local flowing streams and small creeks.

Rains and pop-up storms across the area have contributed to many muddy and murky streams all over. It has made the search for clear water a challenge and has led to explorations of different areas of flowing water. One thing I have observed over the past few summers is that when streams and rivers flood in the warm months they never really return to a clear state until the cooler weather of fall returns.

Have you ever wondered, though, just how these flowing streams received their names? Many of the names exist in various different locations across the state. Buck Creek and Doe Creek undoubtedly received their names from the respective deer that appeared along their shores. I am not a deer hunter but from seeing the multitude of deer tracks along the shores I wade, that if I were to pursue deer this is surely where I would set up camp. Goose Creek must have been named for flocks of geese that "settled in" on the waters that flow through it and Beaver Creek surely must have been home to the native beaver. Judging from their comeback since the early 1970's it seems that almost every creek could be named Beaver Creek. Panther Creek must have received its name when the Eastern Cougar patrolled the shores of the water. And even though they are not supposed to inhabit the area today there sure are an awful lot of sightings. Bear Creek came about when the Black Bear was native to the area and across eastern Kentucky many creeks bear this name or could be named again with the rise in Black Bears across the region. Eagle Creek paid homage to the Bald Eagle and after being absent for many years this regal bird glides the bodies of water again all across the state.

There are many other names that run the gauntlet of events and places in our country. Indian Creek would surely have been named for Native Americans from the various tribes that staked claim to different portions of North America. Our ancestors that came to these shores no doubt make us descendants of immigrants. Silver Creek probably owes its name to prospectors who came to this area in search of riches. Still today, people search for the location of Swift's mine which purportedly exists in this area of eastern Kentucky. Salt Lick Creek had to be where humans and animals went to get their salt for cooking or minerals for life. Elkhorn Creek must have been where elk once resided and maybe some inhabitants found their massive antlers shed around this body of water. Buffalo Creek reminds us that this mighty animal that is associated with the western part of our country also resided in the valleys of our state as well.

But there are some names that are hard to define. Did sturgeon fish ever reside in Sturgeon Creek? How many people perished over the years from the flood waters of Drowning Creek? Was Paint Lick named by the Native American population or did another story exist here? And then there must have been several creeks where problems existed. Hence the names of Troublesome Creek, Hell's Creek, Poor Fork, Defeated Creek, Squabble Creek, Illwill Creek, and maybe a large battle took place at the War Fork. We all love our

grandparents so how did the name Granny Dismal Creek come about"

The list of creeks and corresponding names could go on and on but each rolling body of water would have many stories to tell. They tell a story of life and the embodiment of all who forded the flow of water that travels on larger than life itself.

Norman Maclean, in his book, wrote "Eventually, all things merge into one and a river runs through it. The river was cut by the world's great flood and runs over rocks from the basement of time. On some of the rocks are timeless raindrops. Under the rocks are words, and some of the words are theirs. I am haunted by waters."

The names give us reference to the creeks but it is not the names that define them. As I gaze up these streams I am not haunted but I am grateful that they are a part of my life and that I have been a part of theirs.

After a wet fall and spring, many grass pastures and hayfields may need reseeding. Fall is an optimum time for planting cool season grasses. Farmers should be considering what steps to take to ensure a successful planting.

There are a lot of good agronomic and economic reasons to do everything to increase the probability of getting a good thick, dense, weed-free stand of whatever forage is planted, said Garry Lacefield, retired Extension forage specialist and Professor Emeritus of the UK College of Agriculture Food & Environment. "If you have to reseed, it more than doubles the cost of establishing," he said. "Plus, a lot of Kentucky's forages are grown on rolling land, so if we don't get it established it opens up the possibility of erosion."

To increase the chances of getting a good stand established, it is important to remember and stick to the basics. That includes taking a look at what forages already exist on the farm so the new seeding will be

forage type, farmers should look at their soils to determine what they are capable of growing, he said. Get more specific with soils and take a soil test. A soil test is the most economically important thing a farmer can do relative to fertility. Knowing the baseline fertility, you can determine what nutrients are needed for the particular forage crop.

Be sure to fertilize to the level needed for what will ultimately be in the field, Lacefield said. If you plan to sow red clover in the spring into a field that was seeded with fescue the previous fall, then any fertilizer added that fall must also meet the fertility requirements for clover establishment.

After determining the forage crop to be planted, it is extremely important to determine what varieties will be used, he said. The University of Kentucky has an aggressive variety-testing program. Testing is done many locations in across the state on all species agronomically important to Kentucky. Lacefield recommends farmers visit their county Extension agent or go to the UK College of Agriculture's Web site to resuccess and failure," Lacefield said. "It can make the difference between making money or losing money."

Seeding method is another basic ingredient to a successful forage crop. There are several methods that work well in Kentucky overseeding, preparing seedbeds, and no-till. The key is to have good seed to soil contact and seed at the right depth and rate. Most forage seedings are at a very shallow depth -- usually a quarter to halfinch.

Seeding dates also are important. Often if conditions are dry, farmers tend to wait and can miss the window of opportunity for sowing these crops. Grasses can be planted into October but it is best to get them in between the middle of August to late September.

Following these basic steps will go a long way in ensuring a successful forage stand. "Who knows where the different regulatory entities are going to end up on sports betting, and we just want to make sure we're ready to be able to respond to it." For now, the games are free to play and the network will give away \$1,000 in cash to one winner per quarter of each game. "We think this is the way of the future. There's going to be a gamification of television broadcasts, and this is one of the first examples of it," Phillips said.

Coach Zac Taylor said Green had surgery Tuesday morning and likely won't be ready for the start of the season. Cincinnati opens at Seattle on Sept. 8 and then hosts San Francisco. The Bengals visit Buffalo the third week followed by a

Monday night game at Pittsburgh on Sept. 30. "He's going to miss

It's the second straight season that Green has suffered a significant injury. He missed half of last season with an injured right toe that required surgery. The Bengals went easy with him during offseason workouts, and he felt fully recovered for the start of training camp.
