This is notice that the Salyersville Water Commission is raising the Magoffin County Water District's wholesale water rate for one thousand gallons of water from \$2.72 to \$2.88. This is a 6% rate of increase. This rate is expected to be in place for our August 2019 billing.

As required by our wholesale contract we are raising the rates on our retail customers 6% as well. We will provide the necessary forms required for the Public Service Commission approval.

I calculated using your most recent audit and our sales and usage records that this raise will likely result in less than a 2% increase in your operating expenses. Purchase of water accounts for 32% of your total operating expenses.
