The City of Henderson, Kentucky, and the Henderson Utility Commission, d/b/a Henderson Municipal Power & Light (jointly "Henderson"), in accordance with the Commission's Order dated October 22, 2020, hereby submits the following post-hearing data requests to Applicant Big Rivers Electric Corp. ("Big Rivers"):

- 7. ### **POST-HEARING DATA REQUESTS**

Please provide copies of any and all communications exchanged between Big Rivers and the Energy & Environment Cabinet referencing the ownership of Station Two within the context of the Green Station Title V air emission permit. Include copies of all applications, documents, or other writings filed with the Division of Air Quality.
- 2. Pursuant to the hearing testimony of Mike Pullen at 11:00'00, in which Mr. Pullen updated his written testimony and Big Rivers' response to Henderson data request 1-63, please provide Big Rivers' revised calculations reflecting the total tonnage of waste ever deposited into the Green Landfill, the total number of tons attributable to Station Two, and the total number of Station Two tons attributable to Henderson. Include in your calculations the percentage of total waste you contend is attributable to Henderson for purposes of calculating the percentage of Green Landfill

decommissioning costs you expect Henderson to pay.
