**MOTION TO AMEND EXHIBITS
OF CITY OF HENDERSON, KENTUCKY
AND HENDERSON UTILITY COMMISSION,
d/b/a HENDERSN MUNICIPAL POWER & LIGHT**

Pursuant to 807 KAR 5:001, Section 4(5) and 5, the City of Henderson, Kentucky and Henderson Utility Commission d/b/a Henderson Municipal Power & Light (jointly “Henderson”) hereby moves the Kentucky Public Service Commission for leave to amend the Direct Testimony of Barbara Moll and Exhibits Moll-3 and Moll-4 which were filed on July 14, 2020, in the above-captioned proceeding. The purpose of the amendments is to provide a recalculation of the amount due from Big Rivers to Henderson in settlement of the FY 2018-2019 budget. Exhibit Moll-3 and Exhibit Moll-4 are amended to correct the amount due from Big Rivers to Henderson as a result of the improper capacity reservation from \$561,622 to \$454,090. The testimony and exhibits are further amended to revise the final amount due from Big Rivers to Henderson from \$6,359,736 to \$6,252,304. Henderson respectfully requests that the Commission permit Amended Direct Testimony of Barbara Moll and Amended Exhibits Moll-3 and Moll-4, included as attachments to this Motion, to be filed of record in this proceeding.
