**MOTION OF DUKE ENERGY KENTUCKY, INC.
FOR CONFIDENTIAL TREATMENT**

Comes now Duke Energy Kentucky, Inc. (Duke Energy Kentucky or Company), by counsel, pursuant to 807 KAR 5:001, Section 13 and other law, and respectfully requests the Commission to classify and protect certain information provided by the Company as a hearing exhibit, respectfully stating as follows:

1. On August 1, 2019 Duke Energy Kentucky filed a Notice of Intent to File an Application seeking adjustment of its electric rates and other approvals.
2. On September 3, 2019 Duke Energy Kentucky filed an Application seeking an adjustment of its electric rates and other approvals.
3. The Commission scheduled a formal hearing to being on February 19, 2020.
4. During the course of the hearing, Duke Energy Kentucky entered an Exhibit for which confidential protection was orally requested.
5. The Exhibit is an article prepared by S&P Global Market Intelligence. The

document is subject to copyright protections afforded to S&P Global Market Intelligence under the law of the United States as the publisher of said information. Accordingly, Duke Energy Kentucky must take reasonable steps to assure that the document is not published without the consent of S&P Global Market Intelligence.

6. The Exhibit was acquired by Duke Energy Kentucky on a proprietary basis and is not on file publicly with any public agency, and is not publicly available from any commercial or other source. The aforementioned information is distributed within Duke Energy Kentucky only to those employees who must have access for business reasons, and is generally recognized as confidential and proprietary in the utility industry.

7. Duke Energy Kentucky does not object to limited disclosure of the Confidential Information described herein, pursuant to an acceptable protective agreement entered into with any intervenors with a legitimate interest in reviewing the same for the sole purpose of participating in this case.

8. In accordance with the provisions of 807 KAR 5:001, Section 13(2)(e), the Company is filing one copy of the Confidential Information under seal, and since we are requesting confidential protection for the entire document, no redacted copies will be filed.

9. Duke Energy Kentucky respectfully requests that the Confidential Information be withheld from public disclosure for a period of five years. This will assure that the Confidential Information – if disclosed after that time – will no longer be commercially sensitive so as to likely impair the interests of the Company if publicly disclosed.

10. To the extent the Confidential Information becomes generally available to the public, whether through filings required by other agencies or otherwise, Duke Energy Kentucky

will notify the Commission and have its confidential status removed, pursuant to 807 KAR 5:001 Section 13(10)(a).

WHEREFORE, Duke Energy Kentucky, Inc., respectfully requests that the Commission classify and protect as confidential the specific information described herein.
