MOTION TO AMEND THE PROCEDURAL SCHEDULE

Duke Energy Kentucky, Inc. (Duke Energy Kentucky or Company) respectfully moves this Commission to amend the procedural schedule in its September 9, 2019 Order. On September 30, 2019 the Office of the Attorney General filed a Motion to Intervene Out of Time which was subsequently granted on October 9, 2019. The Office of the Attorney General filed testimony as ordered on December 6, 2019. Currently as ordered, Duke Energy Kentucky does not have an opportunity to file rebuttal testimony after intervenors file their responses to requests for information on January 10, 2020. The Company requests that it be afforded 14 days to prepare rebuttal testimony to be filed on or before January 24, 2020.
