**JOINT MOTION OF DUKE ENERGY KENTUCKY, INC. AND THE  
KENTUCKY ATTORNEY GENERAL**

Come now the parties, Duke Energy Kentucky, Inc. and the Kentucky Office of the Attorney General, each by counsel, and in compliance with the Commission's January 2, 2020 order hereby jointly move that the Commission grant them another thirty (30) days within which to explore the possibility of reaching a settlement of all issues in the instant docket prior to filing a request for a hearing, or alternatively recommending that the matter be submitted on the record.

In support of this motion, counsel state that the Commission's order dated January 2, 2020 amended the procedural schedule in this matter to require that the parties no later than January 31, 2020 file a request for either an evidentiary hearing or that the matter can be decided upon the record. The parties are actively exploring settlement possibilities, but require additional time within which to do so prior to deciding whether to request a hearing or recommending that the case be decided on the record.

WHEREFORE, the joint parties respectfully request that the Commission grant their motion.
