**LOUISVILLE GAS AND ELECTRIC COMPANY'S**  
**NOTICE REGARDING SUBMISSION ON THE RECORD**

Louisville Gas and Electric Company (“LG&E” or “Company”) hereby notifies the Commission that it agrees with the Attorney General’s December 23, 2019 proposal to submit this case on the existing record. In addition, the Company respectfully requests a decision in this matter by February 21, 2020 if possible. As discussed in the Application<sup>1</sup> and in Mr. Conroy’s Direct Testimony,<sup>2</sup> the Company will make its customary annual filing updating the gas line tracker rates on or about February 28, 2020. If a decision is reached in this matter no later than February 21, 2020, the Company will be able to incorporate the results of that decision into its February 28, 2020 annual filing efficiently. The effective date of the new rates would, of course, still be April 1, 2020.

**WHEREFORE**, Louisville Gas and Electric Company respectfully requests that the Commission decide this case on the existing record and no later than February 21, 2020.


