MOTION TO AMEND STYLE OF CASE

Comes now Jackson Purchase Energy Corporation (“Jackson Purchase”), by counsel, pursuant to KAR 5:001, Section 4 and other applicable law, and for its Motion requesting that the Kentucky Public Service Commission (“Commission”) amend the style of the case, respectfully states as follows:

1. On September 4, 2019 Jackson Purchase filed a Notice of Intent to Use Electronic Filing Procedures (“Notice of Intent”).

2. In the September 4, 2019 Notice of Intent, Jackson Purchase indicated that the Application would be for both a Certificate of Public Convenience and Necessity (“CPCN”) and financing approval.

3. Since the filing of that Notice of Intent, Jackson Purchase has determined that the short-term line of credit (“LOC”), will have a payback period of less than two years, which does not require Commission approval under KRS 278.300(8).

4. Contemporaneously with this Motion, Jackson Purchase has filed an Application requesting an Order from the Commission granting a Certificate of Public Convenience and

Necessity (“CPCN”) for the construction of a new headquarters facility. Jackson Purchase intends to acquire an existing building within its service territory and construct/remodel to accommodate its needs for a new headquarters facility.

WHEREFORE, on the basis of the foregoing, Jackson Purchase respectfully requests that the Commission amend the case style to reflect that Jackson Purchase is only requesting a CPCN and no financing approval is being sought.
