Request of Community Action Kentucky, Inc. ("CAK")

for Extension of Time to File Agency Subcontracts

On June 2, 2020, in accordance with the May 4, 2020 Order of Commission in the above

matter (the "Order"), CAK gave notice that its Board of Directors agreed that CAK may serve as the

single administering agency for the HEA programs, subject to the terms of the Order, the agreement

of all parties to the contracts to be made pursuant to the Order and approval of those contracts by the

Commission. On or about Wednesday, August 26, 2020, a draft of the utility contract template, a copy

of which has been supplied to the Commission, was distributed for review by the utilities that are

parties to this Case. As of September 1, 2020, CAK is still awaiting approval of the draft utility

contract by all utilities and, upon said approvals, will thereupon submit the draft utility contract for

approval by the Commission. Once the Commission approves of the utility contract template, CAK

will promptly proceed to execute the agency subcontracts.

The Commission having confirmed June 2, 2020 as the "selection date" of CAK as the

administering agency, the 90-day clock set forth in the Order to have agency subcontracts in place

will expire on September 2, 2020. Because the execution of the agency subcontracts is dependent

upon first obtaining the necessary approvals of the utility contract template, and estimating that such

approvals followed by execution of multiple agency subcontracts will require additional time to

complete, CAK respectfully requests the Commission for a 2-week extension of time to have the

agency subcontracts in place through and including Tuesday, September 15, 2020.
