**MOTION OF LOUISVILLE GAS AND ELECTRIC COMPANY AND
KENTUCKY UTILITIES COMPANY FOR EXTENSION OF TIME**

Louisville Gas and Electric Company (“LG&E”) and Kentucky Utilities Company (“KU”) (jointly the “Companies”) petition the Kentucky Public Service Commission (“Commission”) for an extension of 30 days, through August 14, 2020, to file with the Commission the annual report containing utility-specific information set forth in Appendix B of the Commission's May 4, 2020 Order in this case.

The Companies interpreted the Commission's May 4, 2020 Order to require filing of annual reports beginning July 15, 2021, rather than beginning July 15, 2020. On June 30, 2020, the Companies made annual filings in their old Home Energy Assistance cases for the calendar year 2019.¹ However, additional information is requested in Appendix B of the Commission’s Order of May 4, 2020 and therefore additional time is needed to file all of the requested data for calendar

year 2019. Going forward, the Companies expect to provide full calendar year information in annual filings. As a result, the data for calendar year 2020 will be filed by July 15, 2021.

WHEREFORE, Louisville Gas and Electric Company and Kentucky Utilities Company respectfully request that the Commission enter an Order granting the Companies an extension through August 14, 2020, to file the annual report containing calendar year 2019 utility-specific information set forth in Appendix B of the Commission's May 4, 2020 Order.
