MOTION FOR CONFIDENTIAL TREATMENT

Comes now FR Utility, LLC and Fox Run Living, LLC, (“Fox Run”) by and through counsel, pursuant to KRS 61.878 and 807 KAR 5:001, Section 13, and seeks confidential treatment for certain information filed in response to the Commission’s January 17, 2020 Order.

The information provided in the General Ledger Trial Balance entries contain financial information pertaining to the purchase and operation of the utility assets. This confidential information is commercially sensitive and not publicly available. Making this confidential information public would place FR Utility at a disadvantage with regards to its competitors and potential sellers of other assets. If potential sellers of other assets or competitors seeking to purchase the same or similar assets were aware of the confidential information, it would place FR Utility at a distinct commercial disadvantage.

Fox Run and FR Utility requests that the Confidential Information be withheld from public disclosure for a period of ten years. Preventing the public disclosure of the Confidential Information for ten years ensures that it’s commercial value to Fox Run and FR Utility’s competitors and potential sellers will be of limited value.

WHEREFORE, Fox Run and FR Utility requests that the Commission enter an Order granting this motion for confidential treatment of certain information filed in response to the Commission's January 17, 2020 Order and keep the Confidential Information from public disclosure for a period of ten years.


