



NOTICE

On February 5, 2020, beginning at 9:30 a.m., Eastern Standard Time, the Public Service Commission will conduct a hearing at its offices at 211 Sower Boulevard, Frankfort, Kentucky to examine the request of Hyden-Leslie County Water District for authorization to execute a short-term assistance agreement with the Kentucky Rural Water Finance Corporation to borrow \$2,935,000-as interim financing for previously constructed water system improvements and subsequently to execute a long-term assistance agreement with the Kentucky Infrastructure Authority to borrow \$2,735,000 to permanently finance those improvements. As part of its review, the Public Service Commission will examine Hyden-Leslie District's inability to obtain permanent financing for the constructed water system improvements in a more expeditious manner. The hearing is open to the public. It will also be streamed live and may be viewed on the Public Service Commission's website at psc.ky.gov.
