Familiar foes, Leslie County and Lee County are longtime 14th Region rivals.

With the win, Leslie County improved to 6-10.

Lee County slipped to 3-14 with the loss.

The Eagles excelled of-

fensively throughout the non-district matchup. Leslie County shot 58.1 percent (36-of-52) from the field. The Eagles were 7-of-12 (58.3 percent) were from 3-point range.

Leslie County was 1-of-2 from the free throw line

Trenton Day led Leslie County with 17 points. Day was 3-of-4 from 3-point range.

Treyton Abner accompanied Day in double figures in scoring for the Eagles, adding 14 points. Trent Asher netted eight points for the Eagles while Jason Baker, Wyatt Hensley and Derek Baker posted six points apiece.

The additional scorers for Leslie County in the victory were Ethan Wolfe (five points), Andrew Hacker (four points), John Buckle (four points), Christian Lewis (four points), Colton Hensley (four points) and Trenton RIce (two points).

Trio leads Eagles past Pike County Central

Leslie County returned to the win column over the weekend, upending host Pike County Central, an opponent from the neighboring 15th Region, 71-65 in a boys' high school basketball game on Saturday. Leslie County featured three scorers in double figures in the victory over Pike County Central. Treyton Abner led Leslie County with a game-high 22 points. Abner was 9-of-12 from the field. Finishing directly behind Abner in the Leslie County scoring column, Trenton Day netted 21 points. Accompanying Abner and Day in double figures for the Eagles, Wyatt Hensley posted 19 points.

Leslie County thrived offensively, shooting 63.4 percent (26-of-41) from the field. The Eagles were 7-of-11 (63.6 percent) from 3-point range.

Leslie County was 12-of-23 (52.2 percent) from the free throw line, connecting on over half of its foul shots.

Five players accounted for all of Leslie County's scoring. Trent Asher and Jason Baker rounded out Leslie County's individual scoring, chipping in five points and four points, respectively.

Pike County Central shot 51.1 percent (23-of-43) from the field. The Hawks were 5-of-15 (33.3 percent) from 3-point range.

Pike County Central shot 63.6 percent (14-of-22) from the free throw line Anthony Palotta paced Pike County Central, scoring 21 points and claiming eight rebounds. Pike County Central also featured three scorers in double figures. Jacob Young netted 19 points for the Hawks while Bryce Adkins added 13 points.

Narrowly missing double figures for Pike County Central, Logan Wood contributed nine points.

On February 5, 2020, beginning at 9:30 a.m., Eastern Standard Time, the Public Service Commission will conduct a hearing at its offices at 211 Sower Boulevard, Frankfort, Kentucky to examine the request of Hyden-Leslie County Water District for authorization to execute a short-term assistance agreement with the Kentucky Rural Water Finance Corporation to borrow \$2,935,00-as interim financing for previously constructed water system improvements and subsequently to execute a long-term assistance agreement with the Kentucky Infrastructure Authority to borrow \$2,735,000 to permanently finance those improvements. As part of its review, the Public Service Commission will examine Hyden-Leslie District's inability to obtain permanent financing for the constructed water system improvements in a more expeditious manner. The hearing is open to the public. It will also be streamed live and may be viewed on the Public Service Commission's website at psc. ky.gov.
