**JOINT MOTION OF
LOUISVILLE GAS AND ELECTRIC COMPANY
AND THE ATTORNEY GENERAL
TO MODIFY HEARING DATE**

Louisville Gas and Electric Company (“LG&E” or the “Company”) and the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention Office of the Attorney General, pursuant to 807 KAR 5:001, Section 5, respectfully petition the Kentucky Public Service Commission (“Commission”) to modify the hearing date in this proceeding as set forth below.


On June 4, 2020, the Commission issued an order setting the hearing date for June 17, 2020. Unfortunately, the primary counsel for the Office of the Attorney General in this matter is unavailable on this date due to personal reasons. In addition, pursuant to 807 KAR 5:001, Section 9(2)(b)(2), notice is required to be published at least one (1) time and not less than seven (7) nor more than twenty-one (21) days prior to the hearing in a newspaper of general circulation in the areas that will be affected. As a result, LG&E must

publish notice of the hearing date in eighteen newspapers. If the hearing is held on June 17th, the notice would have to run by June 10, 2020. However, five of the newspapers will not run until at least Thursday, June 11, 2020. In addition, the ability to timely publish by June 10th in the balance of the newspapers is also uncertain.

WHEREFORE, Louisville Gas and Electric Company and the Attorney General respectfully request the Commission to modify the hearing date to accommodate the Attorney General's schedule and to provide more time for LG&E to publish notice to its customers.
