## MOTION FOR EXTENSION OF TIME TO RESPOND TO DATA REQUESTS

Princeton Water and Wastewater Commission ("PWWC"), by counsel, respectfully requests an extension of time to respond to the Commission Staff's Second Request for Information and Caldwell County Water District and Lyon County Water District's ("Water Districts") First Request for Information. In support of this motion, PWWC states the following:

Commission Staff and the Water Districts issued requests for information on February 7, 2020. Pursuant to the scheduling order issued on January 10, 2020, PWWC's responses to those requests for information would be due no later than February 21, 2020. Due to the voluminous nature of the requests, the substantial time required to prepare responses to those request, a family health concern of a critical member of PWWC's staff, PWWC respectfully request a two-week extension through March 6, 2020, by which to provide responses to both sets of requests for information. As a part of this request, it would be appropriate to extend the remaining deadlines identified in Appendix A of the January 10 Order by fourteen days.

PWWC's counsel has contacted the Water District's counsel, who indicated that the Water Districts do not object to the requested extension. Accordingly, PWWC respectfully requests an extension of time through March 6, 2020, to respond to the Commission Staff's Second Request for Information and Water Districts' First Request for Information.
