
Motion for Extension of Time

Western Fleming County Water District ("Western Fleming District"), by Counsel, hereby files its Motion for an Extension of Time to file an alternative rate filing as ordered pursuant ordering paragraph no. 17 of the Commission's Order dated March 30, 2020 issued in this Case.

Western Fleming District requests that the Commission grant an extension of seven (7) months from the required alternative rate filing date of March 30, 2021. Western Fleming District is using Kentucky Rural Water Association ("KRWA") to perform its rate analysis and due to the high volume of ARF cases KRWA is assisting in and the fact that KRWA would like to use Western Fleming District's 2020 fiscal year data which is not yet available, KRWA advised Western Fleming District that the estimated date of completion of the rate analysis would be September 30, 2021.
