**MOTION TO SUBMIT CASE FOR ADJUDICATION
ON THE ADMINISTRATIVE RECORD**

Comes now Taylor County Rural Electric Cooperative Corporation, by counsel, and hereby moves the Kentucky Public Service Commission (“Commission”) to submit the case for a decision based upon the existing record and without the need for a hearing, respectfully stating as follows:

On February 11, 2020, the Commission issued an Order opening an investigation for the six-month review of Taylor County Rural Electric Cooperative Corporation’s application of the Fuel Adjustment Clause from May 1, 2019 through October 31, 2019. The February 11, 2020 Order contained a procedural schedule that allowed for the filing of an affidavit of compliance and a deadline for motions to intervene in the case. There have been no motions for intervention filed in this case. Taylor County Rural Electric Cooperative Corporation has until April 3, 2020, to request a hearing or state that the case should be submitted on the record.

Since there are no intervenors in this case, Taylor County Rural Electric Cooperative Corporation believes the administrative record is complete and it would be appropriate for the

Commission to make a ruling based upon the record. Taylor County Rural Electric Cooperative Corporation respectfully requests a decision from the Commission based upon the existing record.

WHEREFORE, Taylor County Rural Electric Cooperative Corporation moves the Commission to submit the case on the existing administrative record.
