Provide a pressure recording chart showing the actual 24-hour continuously measured pressure available at the locations in the vicinity of all water storage tanks where customers have individual pumps and any other locations necessary to provide a complete understanding of the existing system operation in the areas where customers have individual pumps in Green River Valley District's water system.
- A-6. See Attachment to this Response. These pressure recordings are for five of the six locations where known low water pressure conditions exist. No pressure recording is available for 1150 Bunnell Crossing Road. The service for this residence, however, is approximately 60 feet from the service for 1134 Bunnell Crossing Road. There is minimal difference in elevation between the two services. Therefore, pressure conditions at 1150 Bunnell Crossing Road can reasonably be assumed to be the same as those at 1134 Bunnell Crossing Road.

Individual pumps are installed at residential services along the following roads in Green River Valley Water District's service area: Bunnell Crossing Road, Baumgardner Road, and Bolton School Road. The distribution of water to each of these areas is described below.

Bunnell Crossing Road. Water produced at the District's water treatment plant is pumped into the distribution system using the "South Zones" high service pumps. The high service pumps deliver water to the customers along Bunnell Crossing Road and New Horse Cave Tank. When the high service pumps are not operating the water flows from New Horse Cave Tank to the customers on Bunnell Crossing Road. The overflow elevation of New Horse Cave Tank is 842 feet above sea level (MSL).

Baumgardner Road. The District sells water to Munfordville Water Company. Water is metered into Munfordville Water's system, then metered out and pumped through the Munfordville Pump Station to Pine Ridge Tank and Bonnieville Tank. The overflow elevation of the Pine Ridge Tank is 929.25 feet above sea level (MSL) and the overflow elevation of the Bonnieville Tank is 930 feet MSL. Baumgardner Road is supplied either directly from the pump station or the Bonnieville Tank.

Bolton School Road. Water produced at the District's treatment plant is also pumped into the distribution system using the "North Zones" high service pumps. The high service pumps deliver water to the Magnolia Tank, which has an overflow elevation of 955 feet MSL. Customers along Bolton School Road can be supplied directly from the high service pumps or Magnolia Tank.

Q-8. Explain how the installation of individual pumps complies with the requirements for booster pumps of the "Recommended Standards for Water Works" (Ten State Standards) by the Great Lakes Upper Mississippi River Board of State Public Health and Environmental Managers.

A-8. The installation of the individual pumps does not comply with the *Recommended Standards of Water Works* (2012 ed.). Section 6.4.4 provides: "Private booster pumps shall not be allowed for any individual residential service from the public water supply main." Section 8.11.2 provides: "Individual booster pumps shall not be allowed for any individual residential service from the public water supply mains."

While the Ten States Standards provides that an individual booster pump should not be used for individual residentials service, the Commission has not specifically adopted the Ten States Standards in its regulations or otherwise expressly promulgated a regulation requiring that it be followed. Neither KRS Chapter 318 or the State Plumbing Code (815 KAR Chapter 20) expressly prohibits the use of individual booster pumps. The State Plumbing Code generally governs the water supply piping and equipment located beyond a water utility's delivery point. The International Plumbing Code ("IPC") requires booster pumps in areas with inadequate pressure. IPC Section 604.7. The IPC has also established standards for installation of booster pumps in Section 606.5. There are conditions under which individual booster pumps can be installed without compromising public health and safety. Several states require compliance with both the Ten States Standards and the IPC. The intent of the Ten States Standards is to protect public health and safety by maintaining system pressures above 20 psi under all operating conditions and preventing cross connections which result in the introduction of contaminants into the distribution system. The intent of the International Plumbing Code is the same but provides standards for a safe installation rather than a prohibition.

The use of individual booster pumps to a limited number of customers experiencing low pressure service can be a more cost-effective and efficient means to deliver safe and reliable service to Green River Valley Water District's customers.
