



## NOTICE

Kentucky-American Water Company provides notice that it is filing with the Kentucky Public Service Commission ("Commission") in Case No. 2020-00027 for approval of an amount for its Qualified Infrastructure Program Rider ("QIP Rider") which was approved by the Commission in Case No. 2018-00358. The filing will be made no earlier than March 2, 2020 to be effective on July 1, 2020. The QIP Rider will apply to Residential, Commercial, Industrial, Other Public Authority, Sales for Resale, and Public and Private Fire Service and Hydrant customers. The requested QIP Rider is \$1,603,757. Average usage, in hundreds of gallons, for each customer class to which the QIP Rider applies is: Residential: 39; Commercial: 342; Industrial: 9,713; Other Public Authority: 1,205; Sales for Resale: 18,720; Public and Private Fire Service and Hydrant: 0. Because the QIP Rider is a new rider, it is a 100% increase. Included also is the effect on the average monthly bill for each customer class to which the increased fee applies: Residential: \$0.60 (1.62%); Commercial: \$3.13 (1.62%); Industrial: \$69.76 (1.62%); Other Public Authority: \$11.31 (1.62%); Sales for Resale \$130.56 (1.62%); Public Fire Hydrant: \$0.79 (1.62%); Private Fire Service 6": \$1.29 (1.62%); and Private Fire Hydrant: \$1.24 (1.62%). Any person may examine this tariff filing at Kentucky-American Water Company's offices located at 2300 Richmond Road, Lexington, Kentucky 40502, and on the utility's website at <http://www.amwater.com/kyaw/>. This filing may also be examined at the Public Service Commission's offices located at 211 Sower Boulevard, Frankfort, Kentucky, Monday through Friday, 8:00 a.m. to 4:30 p.m., or through the Commission's website at <http://psc.ky.gov>. Comments regarding this filing may be submitted to the Public Service Commission through its website or by mail to Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602. The fees contained in this notice are the fees proposed by Kentucky-American Water Company, but the Public Service Commission may order fees to be charged that differ from the proposed fees contained in this notice. A person may submit a timely written request for intervention to the Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602, establishing the grounds for the request including the status and interest of the party. If the Commission does not receive a written request for intervention within thirty (30) days of the initial publication or mailing of this notice, the Commission may take final action on the filing.
