APPLICATION TO CONSTRUCT
MERCHANT ELECTRIC GENERATING FACILITY

Pursuant to KRS 278.706 and 807 KAR 5:110, Turkey Creek Solar, LLC (“Turkey Creek”), by counsel, submits this application for a construction certificate to construct a merchant electric generating facility. In support of this application, Turkey Creek states as follows:

1. Turkey Creek is a limited liability company organized under the laws of North Carolina with a principal place of business of 400 W. Main St., Suite 503, Durham, North Carolina 27701. Turkey Creek’s phone number is (919) 682-6822. A copy of Turkey Creek’s Certificate of Authority that is on file with the Kentucky Secretary of State’s office is submitted as Attachment I below.

2. The proposed Turkey Creek Solar Facility will be a 50-megawatt alternating current (MWac) photovoltaic electricity generation facility. The project is to be located in Garrard County, at 1928 Crab Orchard Rd, Lancaster, KY 40444. The power generated by the project will be sold on the open market through the existing transmission line that crosses the property.


3. Pursuant to KRS 278.706 and 807 KAR 5:100, Turkey Creek hereby submits its application fee of \$50,000.00 with this filing.


